## WHAT WE DID IN January and February of this year... The Reentry Program continues to serve returning citizens, most of whom are in recovery. Since the New Year, we have completed 26 intakes with

HOUR AND TRANSITIONAL returning citizens and assisted 32 continuing program participants. As needed, we provided emergency shelter, clothing, bus passes and grocery **PLANNING** cards. We also assisted with union dues and outstanding RMV fees. Mentor activity included encouragement and guidance with employment opportunities, assistance with housing searches and demonstrating how to find and connect with available mental health providers such as the Community Support Program (CSP) or the Behavioral Health Supports for MENTORING Justice Involved Individuals (BH-JI) under the auspices of Community Counseling of Bristol County (CCBC).
